Your security deposit will be charged if the site is damaged, left unclean, if any sporting equipment is not returned, you or your participants fail to vacate the premises by 6:00 PM or you or your participants fail to follow any verbal instructions from Fairmount Park Ranger/Staff on site. Amplified sound or music is prohibited when more than one users is at the facility. Sound must not be heard at Belmont Mansion.

No DJ's or Radio Stations are allowed unless you have express written permission from Fairmount Park . X \_\_\_\_\_

Users are expected to use the amenities with care. Users will be liable for any vandalism or damage done by your group. Due to the large volume of requests for picnic sites, permits are granted on a rain or shine basis. Refunds will not be issued for rained out picnics. Please check the information above (e.g. the date, address, and so on) to insure correct processing of your permit. Once a permit has been issued it is considered **FINAL**. No sales permitted. Amusement Equipment is prohibited.

**Subject to withdrawal without notice.** No person shall commit disorderly conduct of any kind. Charcoal fires permitted only in specially constructed grills. No vehicles or heavy equipment on the grass areas of the park. KEEP YOUR PERMIT WITH YOU AT ALL TIMES DURING THE EVENT. A COPY OF THE PERMIT WILL BE ISSUED TO THE LOCAL POLICE DISTRICT.
