_____ **Alcoholic beverages are prohibited in all areas of the Park except East and West Park.**

_____ **NO SALES PERMITTED WITHOUT THE EXPRESSED WRITTEN PERMISSION OF THE FAIRMOUNT PARK COMMISSION. This includes ALL food and beverages.**

_____ **No vehicles or heavy equipment on the grassy areas of the Park. All areas must be left clean of litter. Failure to do so will result in revocation of this permit and the imposition of costs.**

_____ **Amplified music and/or sound is prohibited.**

_____ **Tents over 100 square feet require a permit from Licenses & Inspection Department.**

_____ **Team will not use fields in wet or muddy conditions, doing so will forfeit the remainder of the permit. Fields should be used in safe conditions only, inspect fields before using and do not use the fields if an unsafe condition exist. KEEP YOUR PERMIT WITH YOU AT ALL TIMES.**

_____ **We will NOT process application without a check or incomplete applications. We do NOT accept faxed or e-mailed copies.**
