Absolutely no amplified sound, music, DJ's, Radio Stations, or inflatable amusement equipment (Moonbounce) are allowed in any Fairmount Park picnic sites/pavilion. X

\*The picnic areas at M.L.King Dr. and Cobbs Creek & Cedar Ave are available from 12 Noon to 6 PM only. X

No vehicles or heavy equipment on the grass areas of the park.

All requests must include the contact person's name, phone number, address, and signature in order to be processed. Due to the large volume of requests for picnic sites, permits are granted on a rain or shine basis. Refunds will not be issued for rained out picnics. Please check the information above (e.g. the date, address, and so on) to insure correct processing of your permit. Once a permit has been issued it is considered **FINAL**. Alcoholic beverages are prohibited. No sales permitted. Grounds are to be left in clean and orderly condition. Subject to withdrawal without notice. No person shall commit disorderly conduct of any kind. Fires permitted only in specially constructed fireplaces. All areas must be left clean of litter. Permission to place port-a-johns at location on the day of the event, units must be removed immediately after the event. Port-a-johns are provided by a CONTRACT SERVICES PROVIDER and are not the responsibility of Park Staff. **KEEP YOUR PERMIT WITH YOU AT ALL TIMES DURING THE EVENT.**

**A COPY OF THE PERMIT WILL BE ISSUED TO THE LOCAL POLICE.**
