_____ **Alcoholic beverages are prohibited in all Park areas except East and West Park.**

_____ **NO SALES ARE PERMITTED. This includes ALL food, beverages, and merchandise.**

_____ **No vehicles or heavy equipment on the grass areas of the Park. All areas must be left clean of litter. Non-compliance will result in revocation of this permit and the imposition of charges.**

_____ **Amplified music and/or sound is prohibited.**

_____ **Tents over 100 square feet in area require a permit from the Department of Licenses & Inspection.**

_____ **Teams will not use the fields in wet or muddy conditions, and doing so will forfeit the remainder of the permit. Fields should be used in safe conditions only. Inspect fields before using and do not use the fields if an unsafe condition exists. PERMIT HOLDERS MUST KEEP THE PERMIT ON-SITE WITH THE FIELD USER AT ALL TIMES.**

_____ **Applications will NOT be processed if submitted incomplete or without payment. Faxed or e-mailed copies of applications cannot be accepted or processed.**

By signing and submitting this application for a permit, I agree to abide by all Park rules, regulations and policies.
