## *General Information*

Permits will be issued for a tournament pursuant to the conditions outlined below. Permits are subject to withdrawal without notice. Donations are NON-REFUNDABLE. Permits are NON-TRANSFERABLE. All application forms must be fully completed in order to be processed. Please check the application for accuracy. The following terms and conditions apply to **all** tournament permits: (Please initial.)

- \_\_\_\_\_ **A minimum security deposit of \$500 is required to protect the Park from damage. Depending on the size of the group and the type of tournament, a larger deposit may be required. THIS DEPOSIT IS REQUIRED FOR ALL TOURNAMENTS, including those given by sports associations, schools and/or for youth tournaments. Parking or driving on grass, service roads or athletic fields is strictly prohibited. Permit holders are responsible for enforcing this rule by their participants, spectators and vendors. Failure to comply automatically forfeits the security deposit.**
- \_\_\_\_\_ **All vending, including food and/or beverages, is prohibited without express written permission from the Fairmount Park Commission.**
- \_\_\_\_\_ **All areas must be left clean of litter. Litter will result in the forfeiture of your security deposit. Depending on the size and type of tournament, your group may be required to deposit funds for post tournament clean-up costs.**
- \_\_\_\_\_ **Port-a-johns may be installed prior to the event and must be removed immediately after the event. Depending on the size of your group, you may be required to provide port-a-johns and/or disposable trash cans.**
- \_\_\_\_\_ **Amplified music and sound are prohibited.**
- \_\_\_\_\_ **Security Deposit checks will be cashed. Refunds will be made 60 days after your event, deducting any costs as necessary.**

**KEEP YOUR PERMIT WITH YOU AT ALL TIMES.**

By signing and submitting this application for a permit, I agree to abide by all Park rules, regulations and policies. I further acknowledge that I may be held responsible for any violation of the rules, regulations and policies. Failure to do so will result in the cancellation of this permit, and the refusal of future permits as well.
